UPGRADE & EDIT OPTION
(ACADEMIC SESSION 2026-27)

It is for the information of all concerned that, after completion of the first phase of B.Ed. admissions for the Academic Session 2026-27, the University of Jammu is opening an **EDIT WINDOW** on the B.Ed. Admission Portal for the candidates who could not be allotted/admitted to any B.Ed. College during the first round of counselling/admission.

Such candidates shall be provided an opportunity to edit/add their preferences of B.Ed. Colleges having vacant seats. The allotment of seats shall be made subsequently on the basis of merit and availability of seats in the respective B.Ed. Colleges.

IMPORTANT GUIDELINES FOR EDIT WINDOW/ALLOTMENT:

1. The Edit Window shall be available only to those candidates who have not been allotted/admitted to any B.Ed. College in the first round of counselling/admission.
2. Candidates eligible to participate in the Edit Window may edit/add their College preferences from amongst the B.Ed. Colleges having vacant seats.
3. Admissions shall be made purely on the basis of Merit among the applicants who present themselves on the day of the counselling.
4. Candidates are advised to exercise their preferences carefully, keeping in view the availability of seats in the respective B.Ed. Colleges.
5. The allotment of seats shall be made strictly on the basis of merit and availability of seats, subject to fulfillment of the prescribed eligibility conditions and other admission rules of the University.
6. Candidates who are allotted a seat through this process shall be required to complete the admission formalities and deposit the prescribed Admission Fee within the stipulated date. Failure to deposit the fee within the prescribed schedule shall result in cancellation of the allotment.
7. **Candidates who have already been allotted/admitted to a B.Ed. College in the first round shall not be eligible to participate in the Edit Window.**
